



## Incoming Inspection Supervisor

### Job description

As an Incoming Inspection Supervisor, you will Coordinate raw materials evaluations to ensure compliance to specifications, define in conjunction with the related functions within Quality and Engineering the best methods to evaluate key characteristics and report inspection results to the appropriate areas.

#### In your new role you will:

- Define and oversee the inspection and verification of raw materials prior to release to production or warehouse.
- Develop and improve inspection methods & sampling plans for new and existing parts.
- Collect and present historic performance data from raw material suppliers at IQA.
- Aid on the investigation of raw material complaints.
- Create and – in conjunction with SQE – follow up DMR's with suppliers.
- Co-Chair the raw materials MRB meeting.
- Communicate DMR's to suppliers and support on establishing containment actions locally.
- Maintain suppliers DMR's database and assure adequate records are kept.
- Support Engineering Evaluations of raw material.
- Perform First Article Inspections.
- Collect SPC and technical data / info from suppliers.
- Maintain Supplier certificate data base.
- Responsible of the FMEA/PCP of the area in charge.
- Ensure that the Incoming Inspection process is effective and in line with the BE guidelines.
- Create and maintain Part Inspection Plans and a harmonized defect catalogue.
- Keep the inspector's trainings current and assess their performance regularly.
- Evaluate IQA inspectors periodically and provide feedback and coaching.
- Measure the inspection cycle and identify opportunities for improvement.
