- Evaluate the defects and be part of the risk assessment to provide the proper disposition to all Non-conformance material and participate actively in MRB
- Assure that all the products of his area of responsibility meet the customer requirements
- **Be the SME on quality criteria**
- Support and present Customer information
- Support and coordinate the activities to perform the quality checks within the process (Meet, PCP, Product Specifications, SPC, etc.)
- Train other engineers/technician/QA in specific processes and in the culture of 0 defects

- Improve and develop new processes and tools. (fixtures)
