This includes continuous improvement of fab operations up-time, production cycle time, yield, and operational productivity. This position will lead the manufacturing team including process engineers, equipment engineers, tool operators, and equipment maintenance technicians and is responsible for all aspects of production. Promote benchmark Safety and Quality in all aspects of the operation.

In your new role you will:
