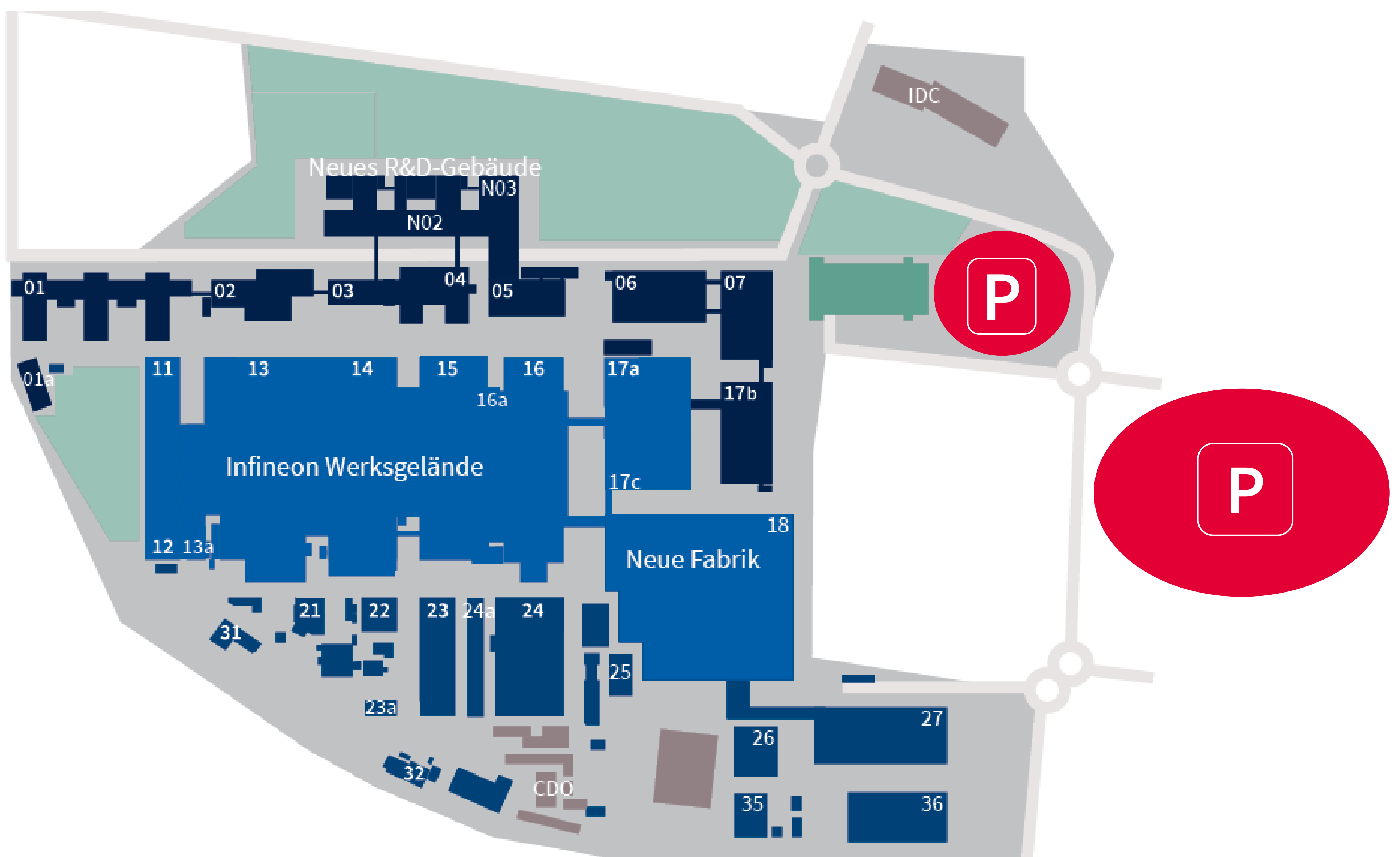

# Current entry requirements

Austria (as of 10.11.2021)

Entry within the framework of regular commuter traffic for professional purposes, is possible with a medical certificate, a vaccination certificate, a convalescence certificate or a test result. If neither a medical certificate nor a test result, a vaccination certificate or a recovery certificate can be presented, a molecular biological test for SARS-CoV-2 or antigen test for SARS-CoV-2 must be carried out immediately, in any case within 24 hours after entry. Additionally, a registration via the [electronic "Pre-travel clearance" form](#) is necessary here prior to entry. The costs for the test have to be paid by the patient. However, registrations for free testing are available through <http://www.oesterreich-testet.at>. The negative test result must be presented at a check-up. If the proof of a negative test result is issued abroad, it must be in German or English. [->more information \(in German\)](#)

We also offer free COVID tests for contractor employees entering Austria for an assignment at the Villach site: Appointment booking is possible by calling 0043(0)5 1777 2404.

# Current COVID 19 measures

## (Status: 18.11.2021)

Due to changes in the legal framework, the following measures will apply at our sites from November 01, 2021:

### 3-G proof at the workplace

All Business Partners are **required by law and therefore are responsible** for carrying a valid 3-G certificate (vaccinated, recovered, tested) together with the Business Partner ID card outside the cleanroom at all times. Only until November 14 can the FFP2 mask be worn as an alternative in the absence of 3-G proof. If you are unable to present proof of testing for health reasons, you must carry an appropriate medical certificate.

Opportunities for vaccination and testing in your area can be found on the nationwide platforms "[Austria vaccinates](#)" and "[Austria tests](#)".

For easy handling of the proof, we recommend the app "[Green Passport](#)" in the Infineon App Store. You can find answers and assistance for obtaining certificates and QR codes in the [FAQs for the app](#). For an overview of the validity of the 3-G proofs, please visit the [website of the Ministry of Health](#).

The corresponding **check of the 3-G proof** at our locations is carried out on a random basis via security.

Please note that the obligation to provide a 3-G certificate is a legal requirement of the business partner and will result in expulsion from the premises in the event of non-compliance.

### FFP2 masks/hygiene measures

**Wearing an FFP2 mask is mandatory in enclosed spaces.** The FFP2 mask requirement does not apply if there is a distance of at least 1.5 meters between the workplaces or if you are the only person sitting at your workstation in an office, whether an open-plan or individual office.

This also applies to:

- break rooms
- coffee kitchens
- Changing rooms and sit-over
- Medical Service Center
- **Canteen and cafeterias:** An FFP2 mask must be worn in the entire canteen area and in building 05, as well as in the CaFETeria and Café Ella, until you take your seat.

The FFP2 mask is not to be worn when consuming food or drink.
