Functional Description

The CY62137EV30 is a high performance CMOS static RAM organized as 128K words by 16 bits. This device features advanced circuit design to provide ultra low active current. This

is ideal for providing More Battery Life™ (MoBL®) in portable applications such as cellular telephones. The device also has an automatic power down feature that significantly reduces power consumption by 90% when addresses are not toggling. The device can also be put into standby mode reducing power consumption when deselected ($\overline{\text{CE}}$ HIGH or both BLE and BHE are HIGH). The input and output pins (I/O_0 through I/O_{15}) are placed in a high impedance state when: deselected ($\overline{\text{CE}}$ HIGH), outputs are disabled ($\overline{\text{OE}}$ HIGH), both Byte High Enable and Byte Low Enable are disabled (BHE, BLE HIGH), or during a write operation ($\overline{\text{CE}}$ LOW and $\overline{\text{WE}}$ LOW).

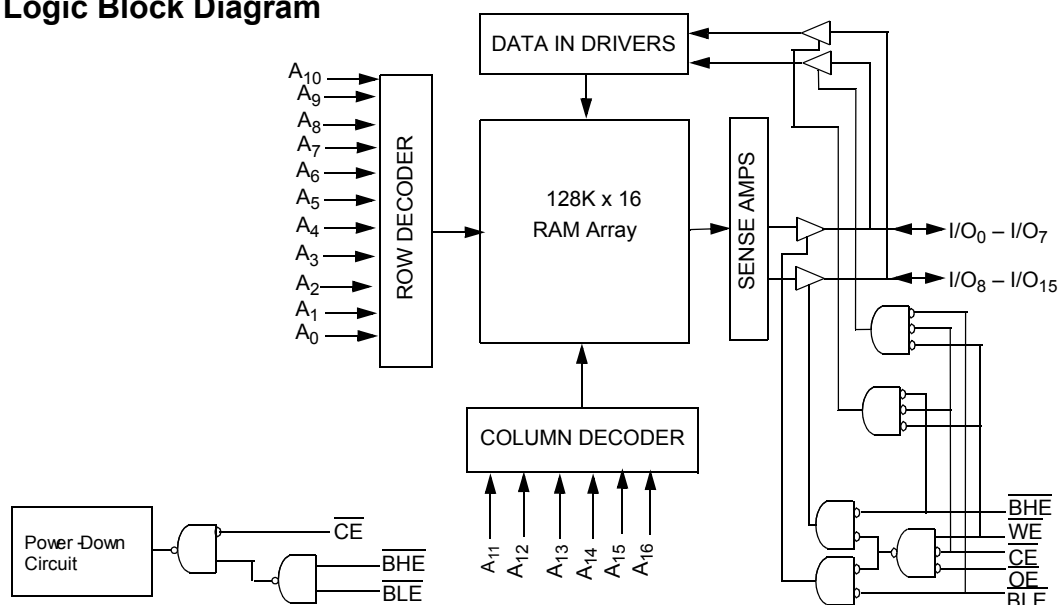
Writing to the device is accomplished by asserting Chip Enable ($\overline{\text{CE}}$) and Write Enable ($\overline{\text{WE}}$) inputs LOW. If Byte Low Enable (BLE) is LOW, then data from I/O pins (I/O_0 through I/O_7), is written into the location specified on the address pins (A_0 through A_{16}). If Byte High Enable (BHE) is LOW, then data from I/O pins (I/O_8 through I/O_{15}) is written into the location specified on the address pins (A_0 through A_{16}).

Reading from the device is accomplished by asserting Chip Enable ($\overline{\text{CE}}$) and Output Enable ($\overline{\text{OE}}$) LOW while forcing the Write Enable ($\overline{\text{WE}}$) HIGH. If Byte Low Enable (BLE) is LOW, then data from the memory location specified by the address pins appears on I/O_0 to I/O_7 . If Byte High Enable (BHE) is LOW, then data from memory appears on I/O_8 to I/O_{15} . See the [Truth Table on page 11](#) for a complete description of read and write modes.

The CY62137EV30 is available in 48-ball VFBGA and 44-pin TSOPII packages.

Figure 1. 48-ball VFBGA pinout (Top View) ^[1, 2]

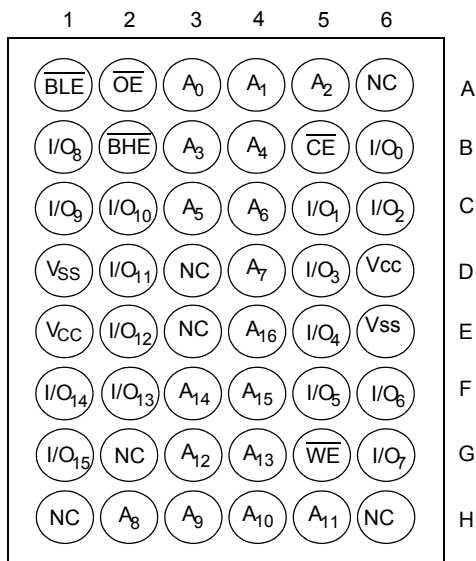
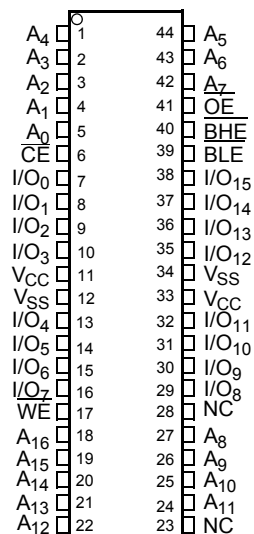


Figure 2. 44-pin TSOP II pinout (Top View) ^[1]

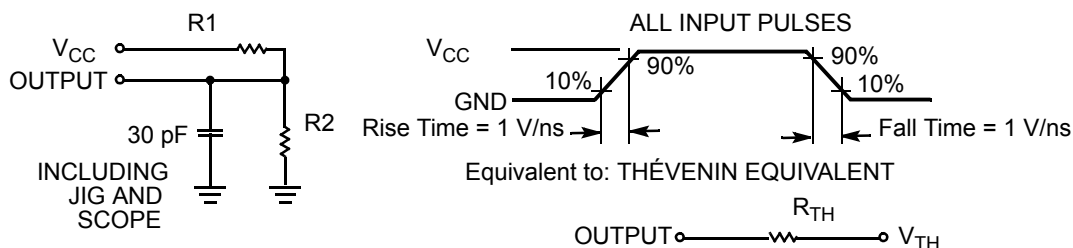

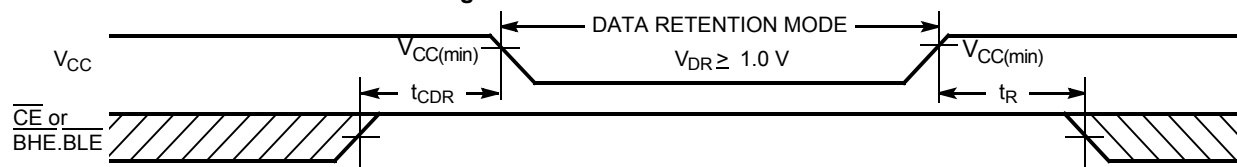

Figure 5. Read Cycle 1: Address Transition Controlled [21, 22]

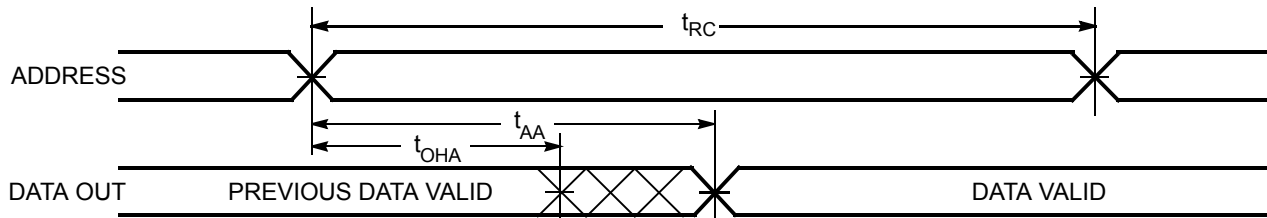
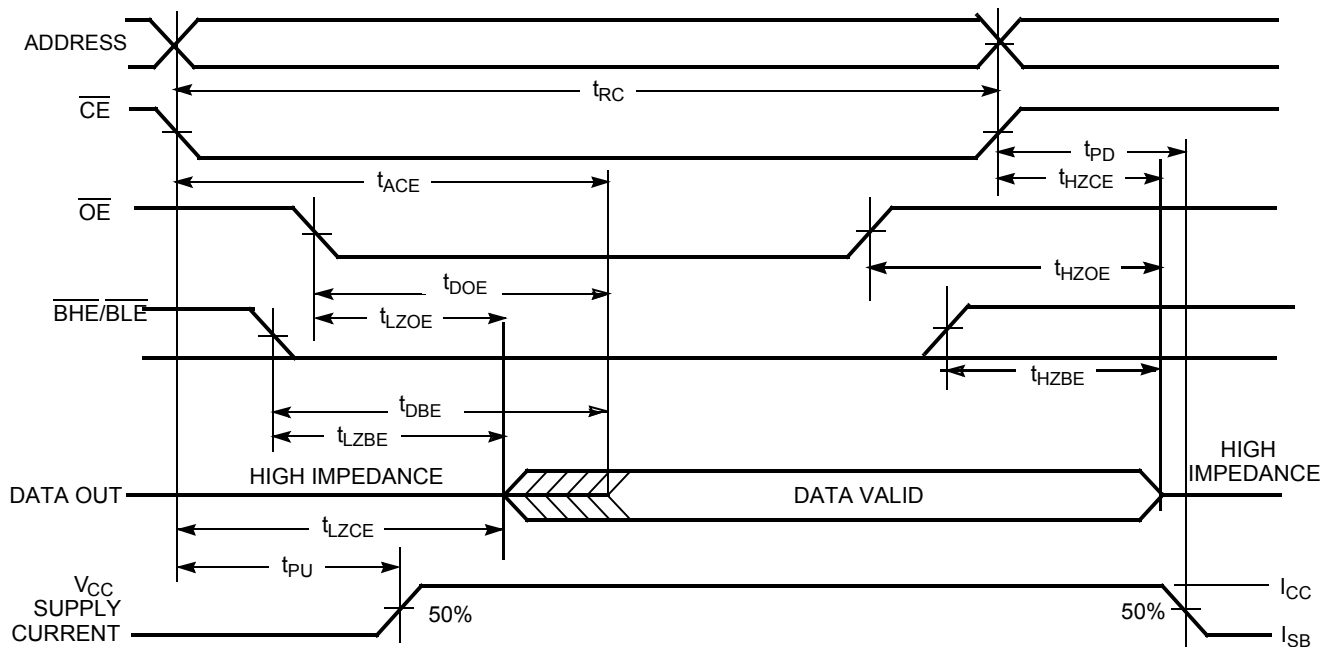
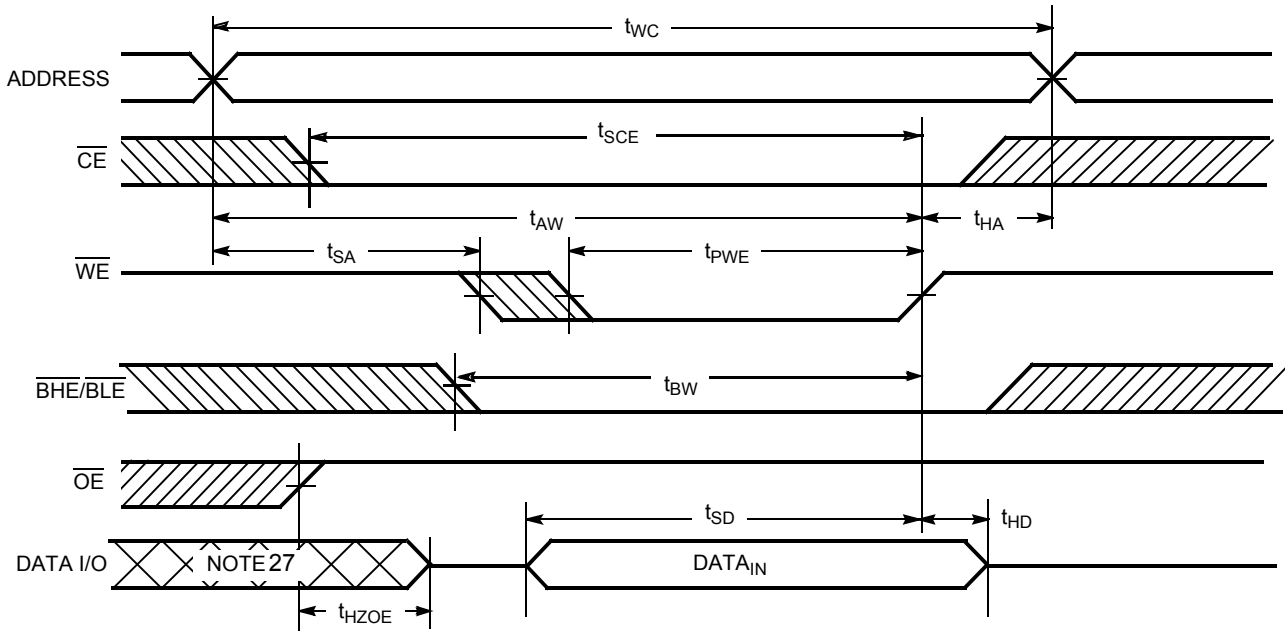
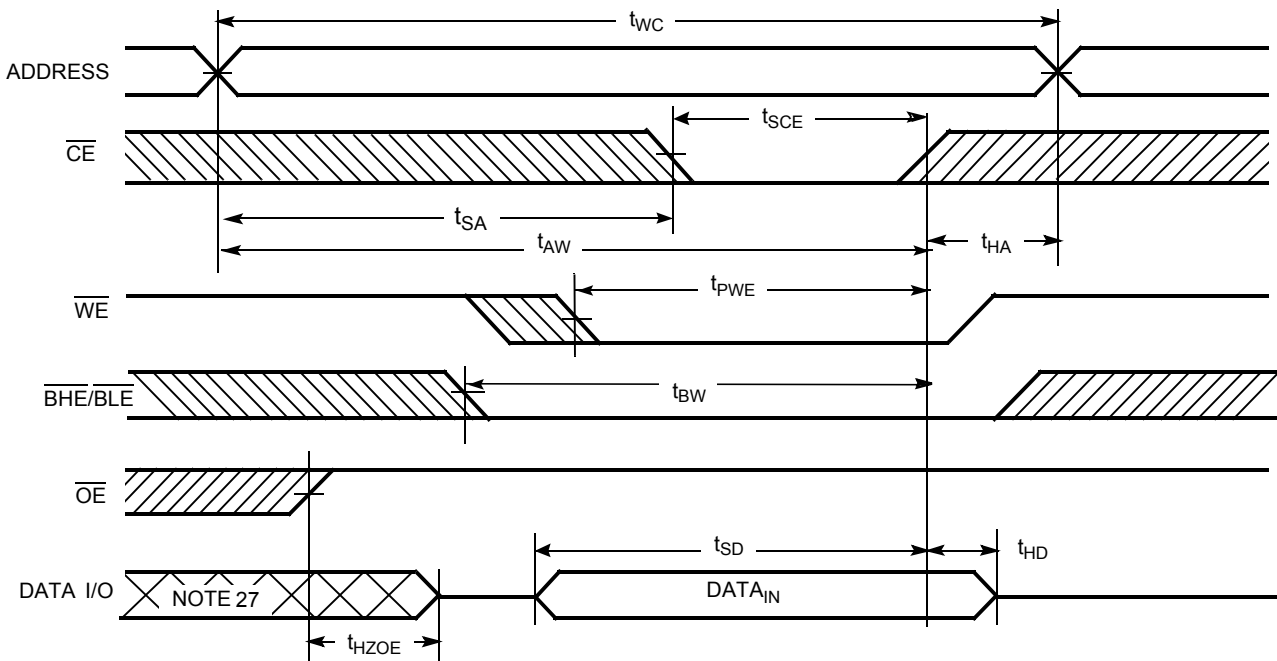


Figure 6. Read Cycle No. 2: $\overline{OE}$ Controlled [22, 23]

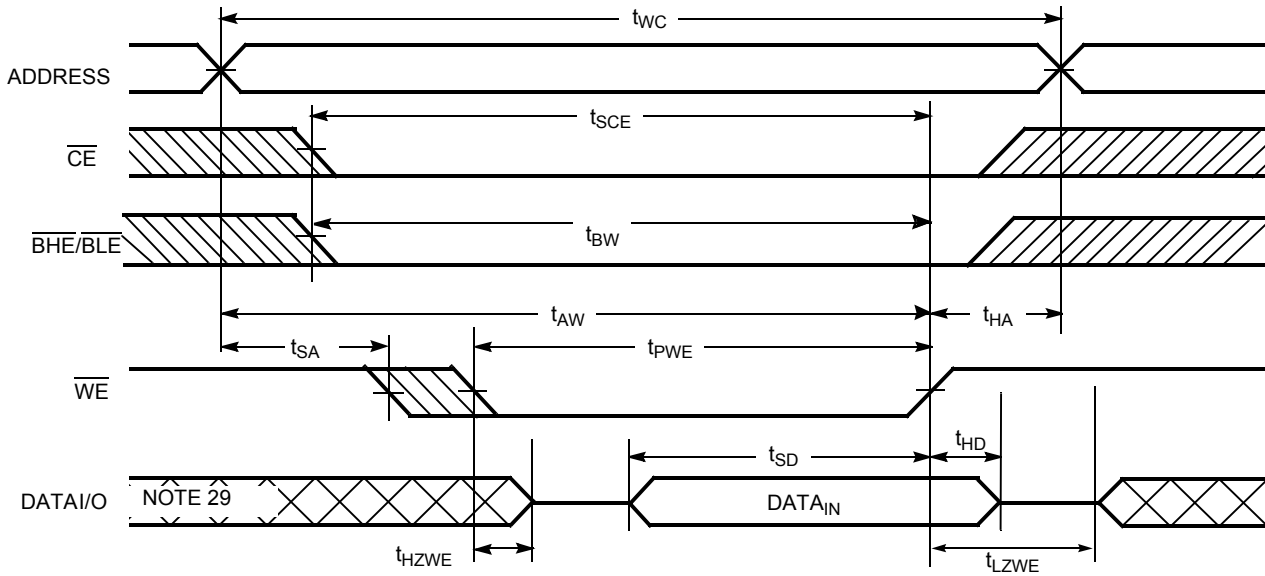
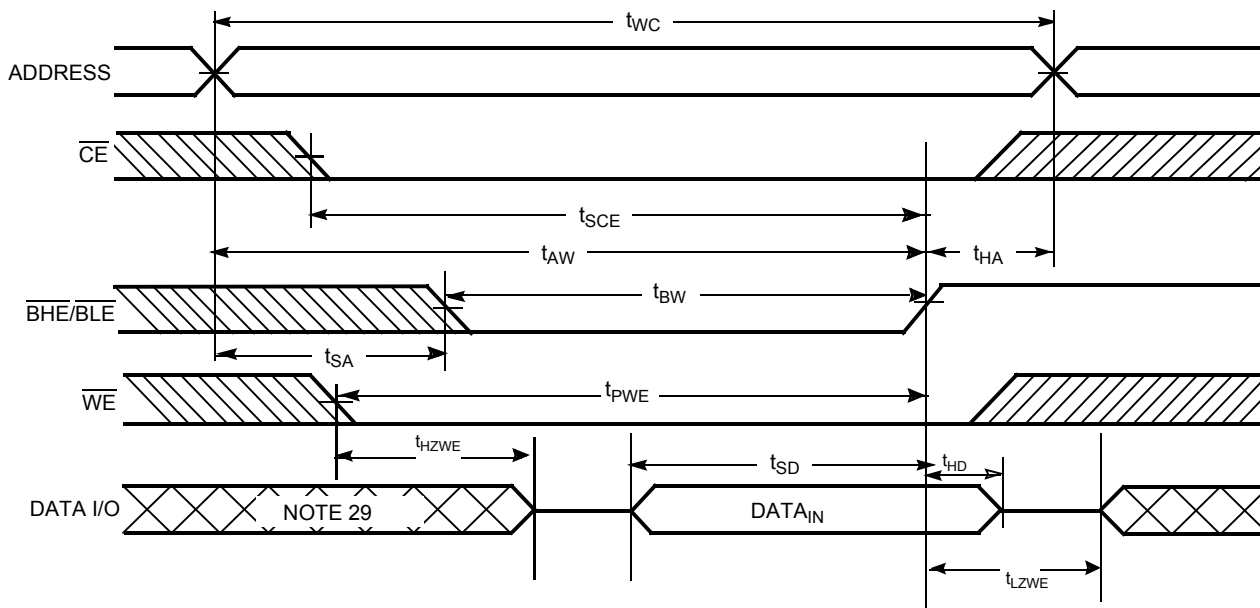

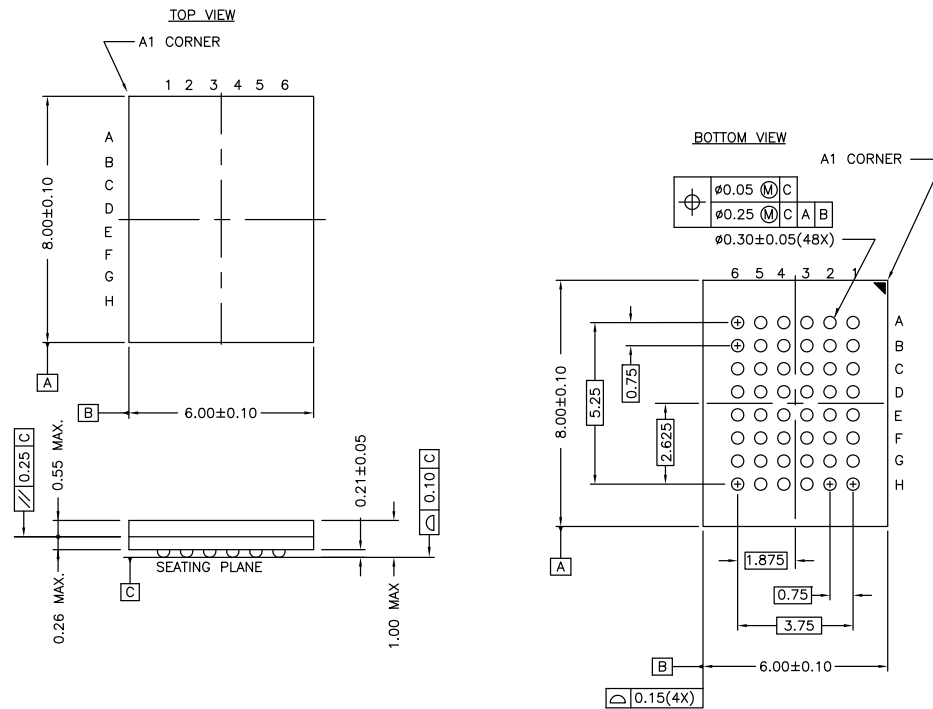

Figure 11. 48-ball VFBGA (6 × 8 × 1.0 mm) BV48/BZ48 Package Outline, 51-85150

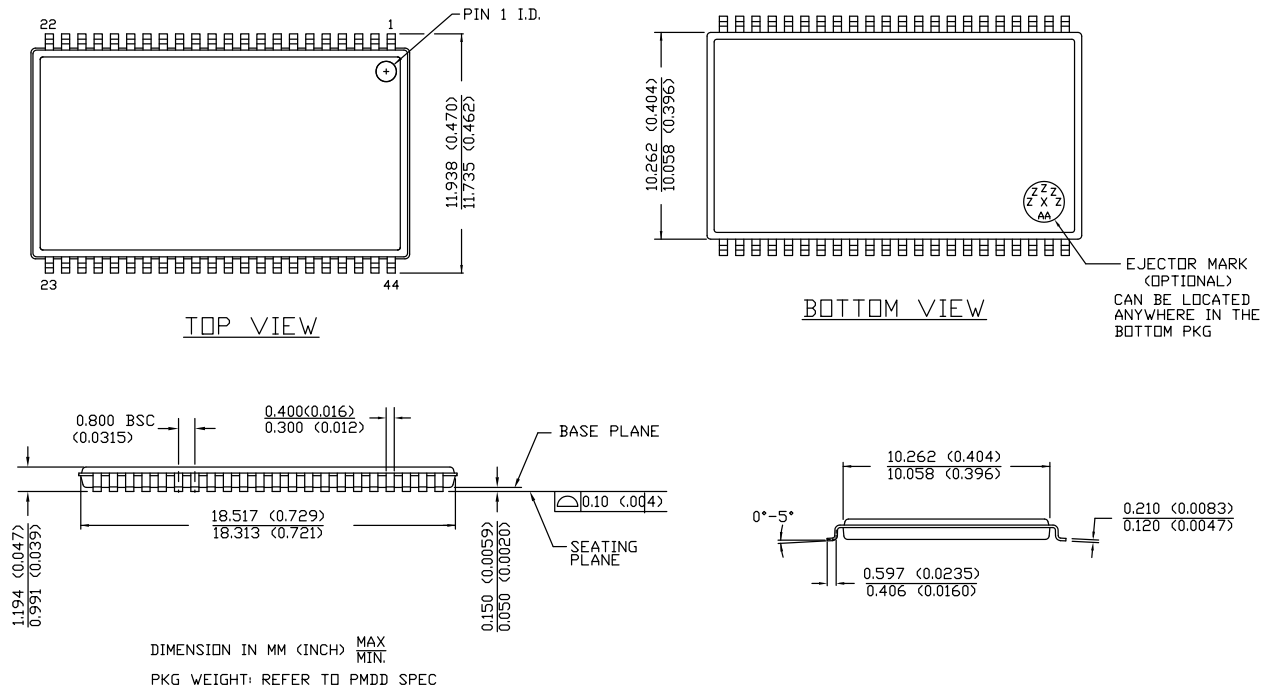
