PSoC Programmer 3.24.0 or later is required to program the PSoC device on the CY8CKIT-042-BLE Bluetooth Low Energy Pioneer Kit. PSoC Creator installation or the kit installation automatically installs PSoC Programmer and KitProg2 drivers.
