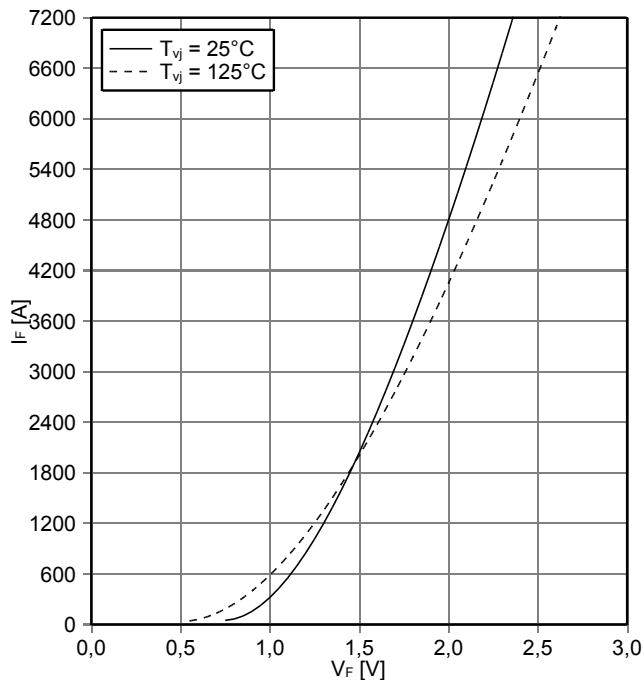

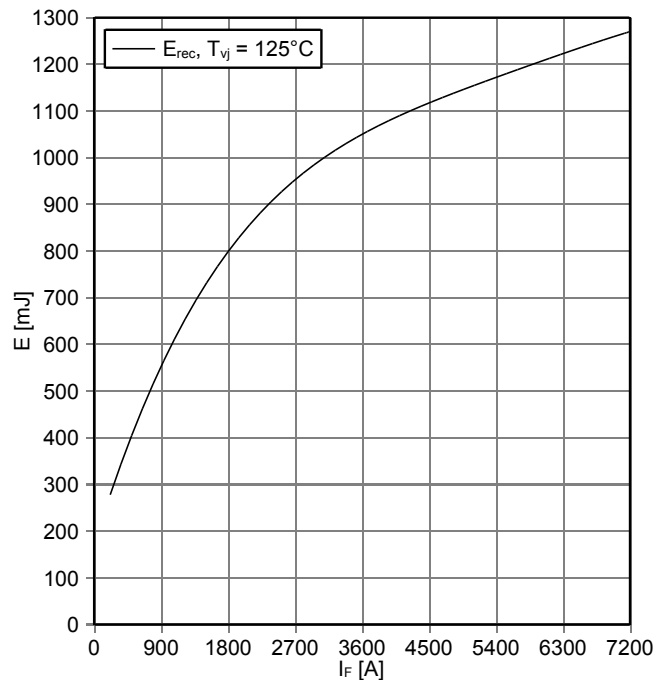

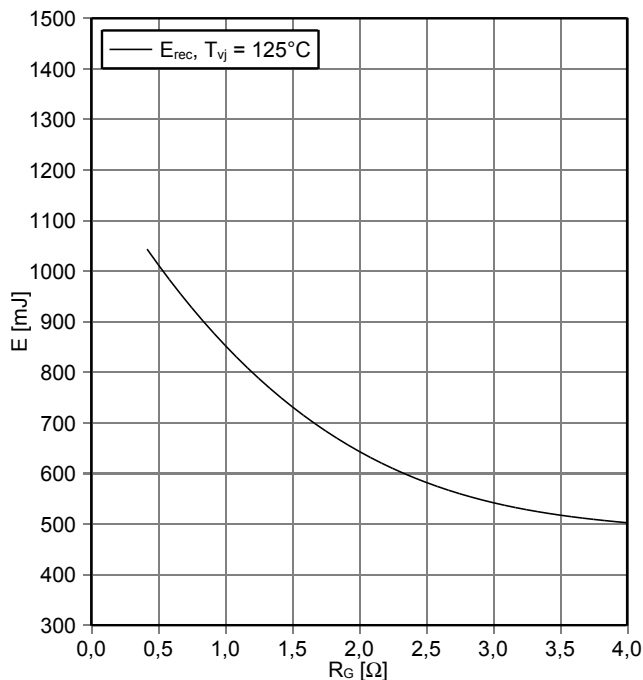

 $I_F = f(V_F)$



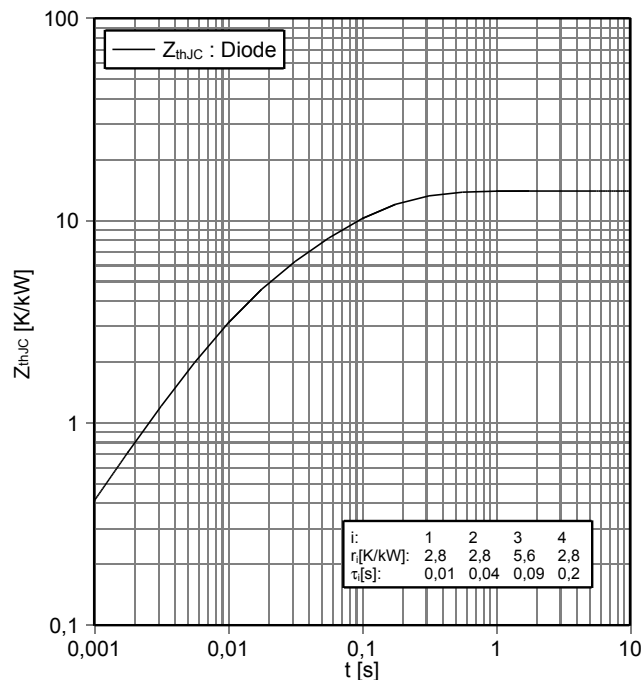
开关损耗 二极管,逆变器 (典型)

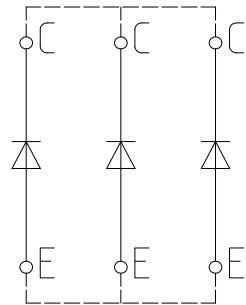


瞬态热阻抗 二极管,逆变器

 $Z_{thJC} = f(t)$



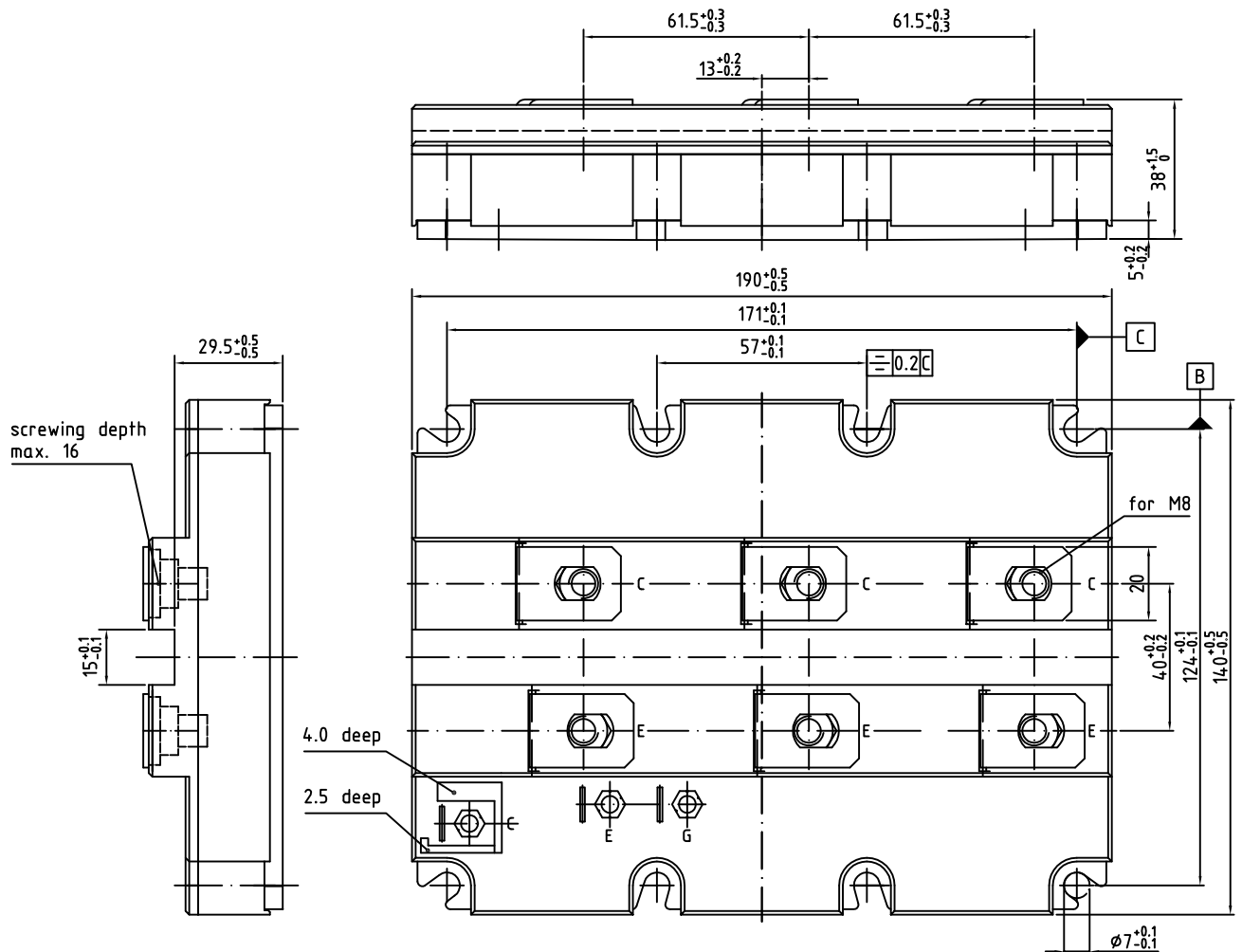
