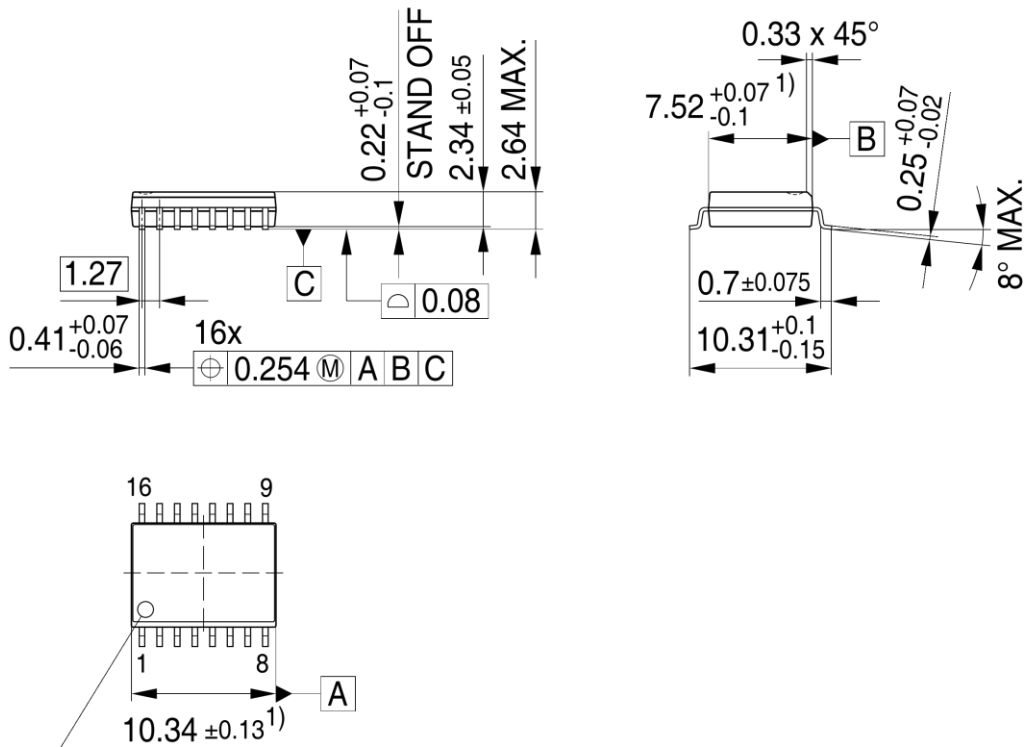

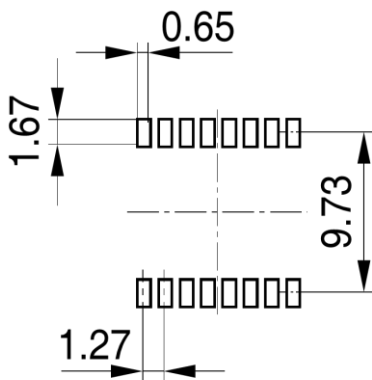

## Footprint Dimensions

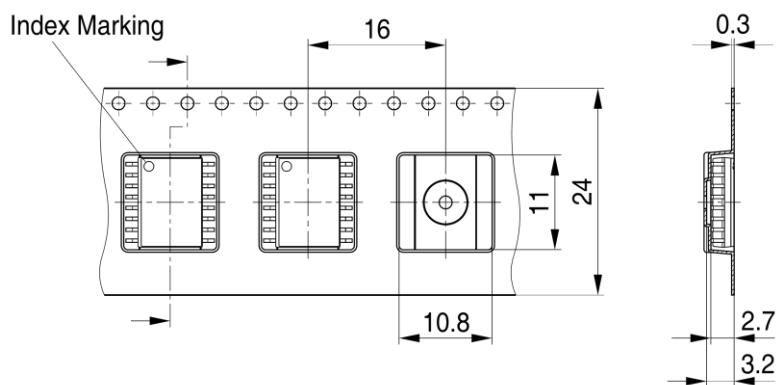

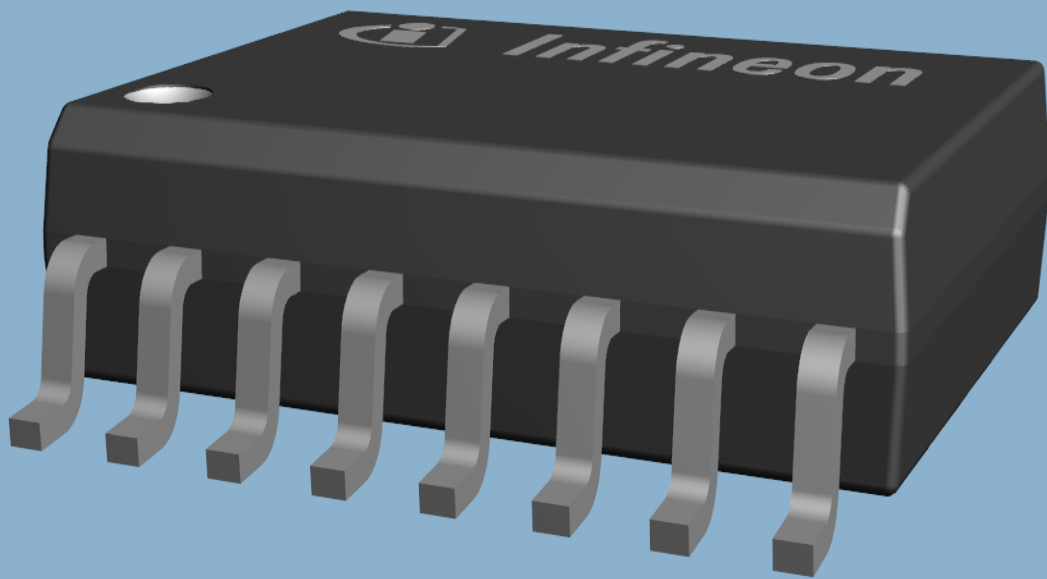
