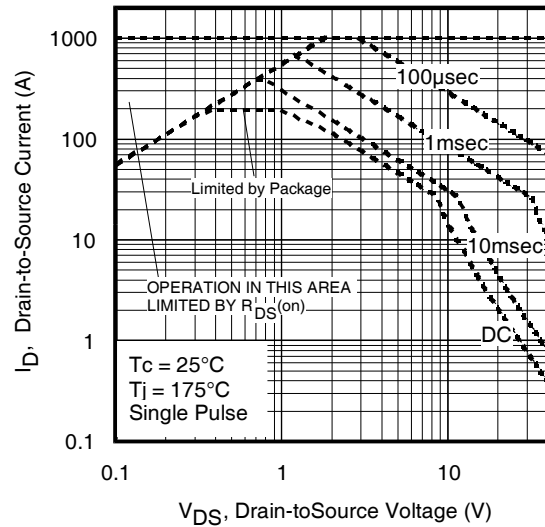


**Fig 5.** Typical Capacitance vs. Drain-to-Source Voltage

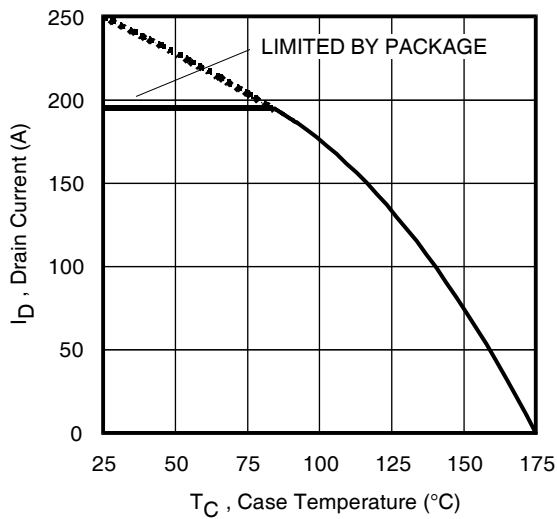
**Fig 6.** Typical Gate Charge vs. Gate-to-Source Voltage



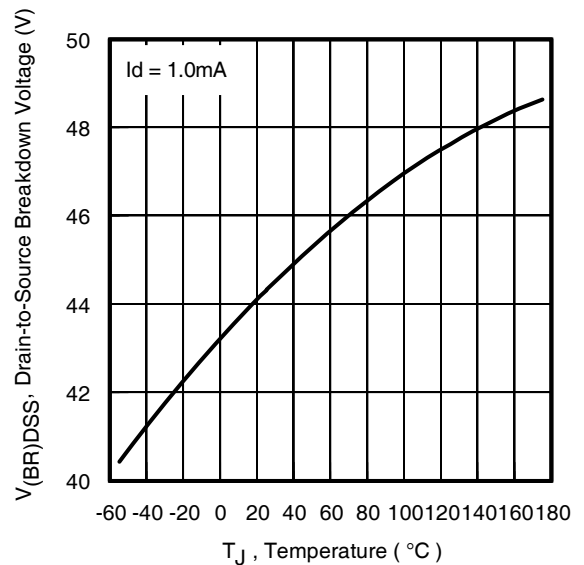
**Fig 7.** Typical Source-Drain Diode Forward Voltage



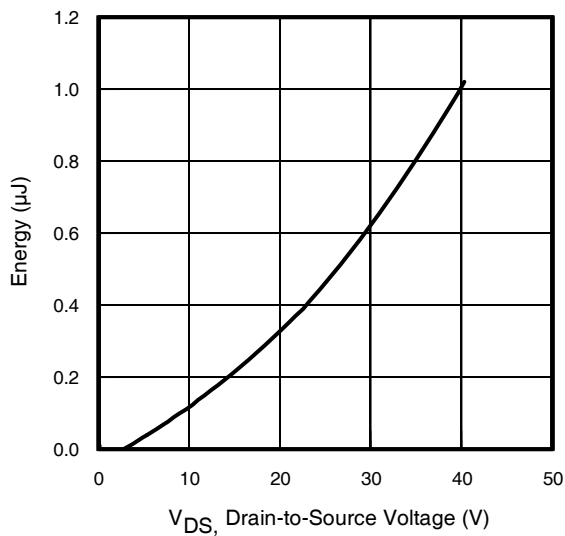
**Fig 8.** Maximum Safe Operating Area



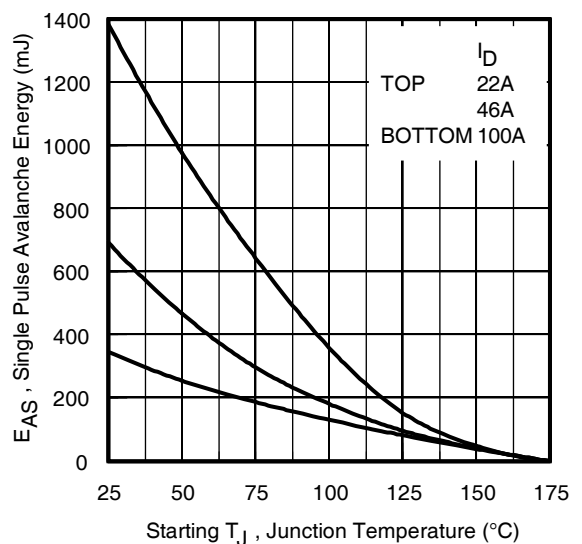
**Fig 9.** Maximum Drain Current vs. Case Temperature



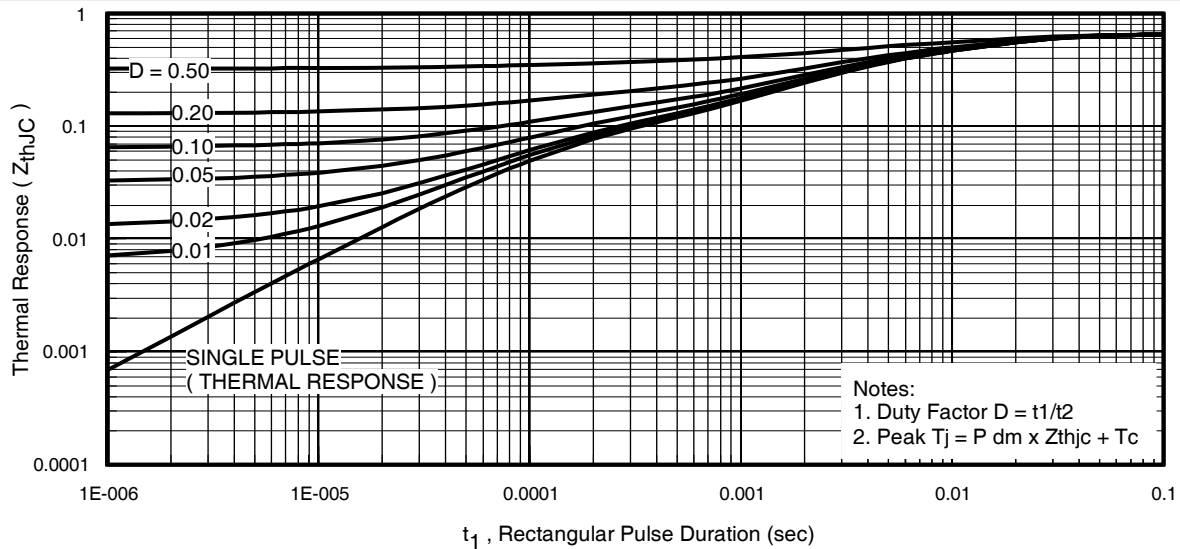
**Fig 10.** Drain-to-Source Breakdown Voltage



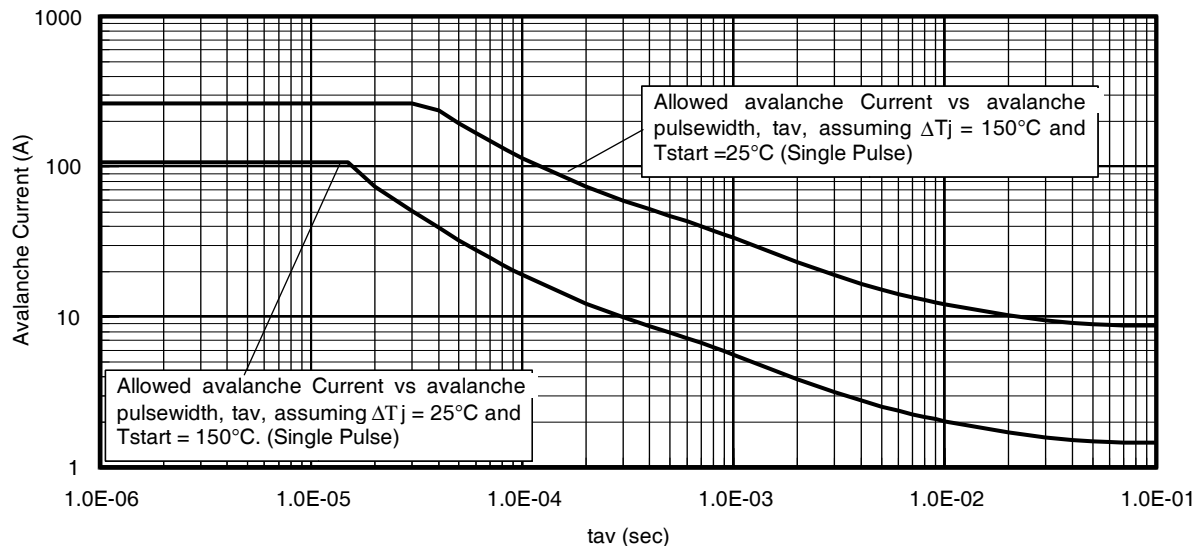
**Fig 11.** Typical  $C_{OSS}$  Stored Energy



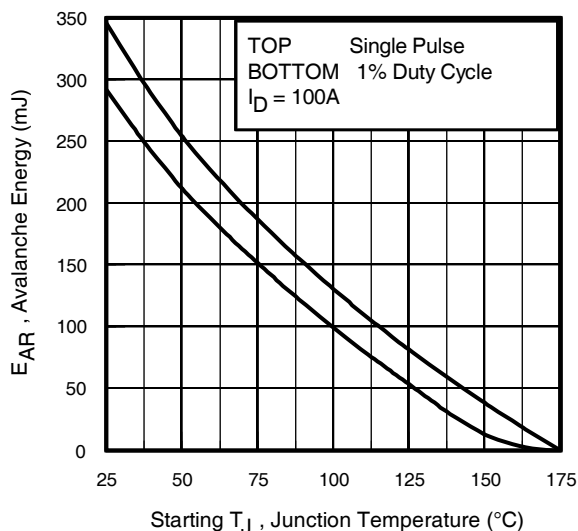
**Fig 12.** Maximum Avalanche Energy vs. Drain Current

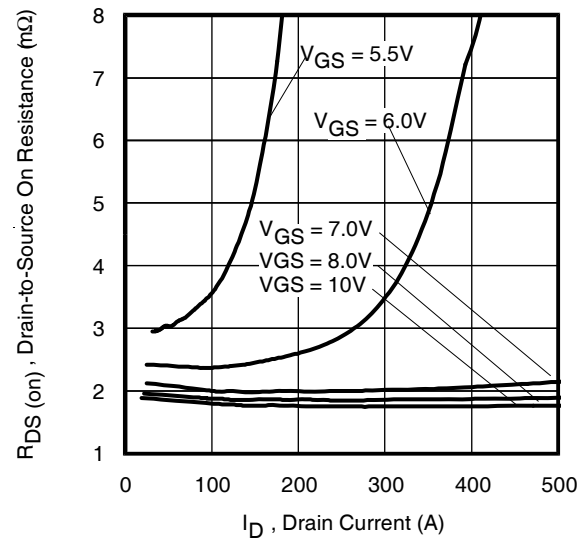

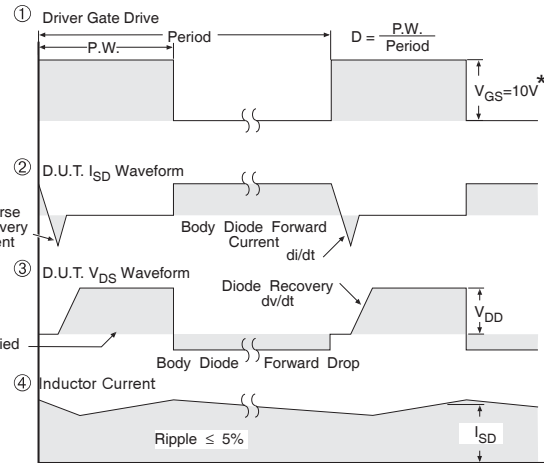
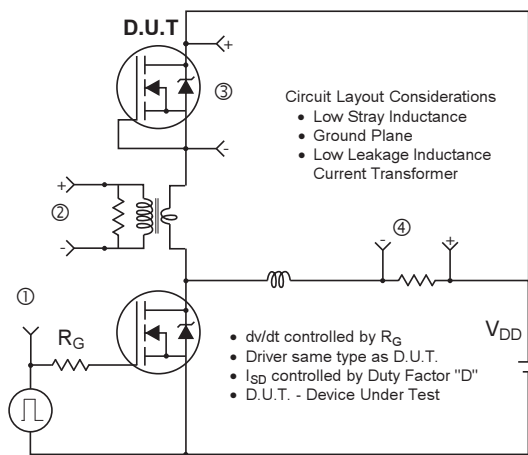
**Fig 15.** Maximum Avalanche Energy vs. Temperature

**Fig. 21 -** Typical Stored Charge vs.  $di_f/dt$



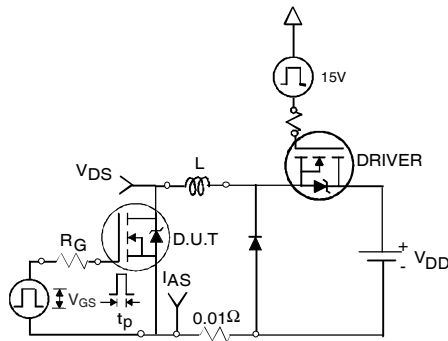
**Fig 22.** Typical On-Resistance vs. Drain Current



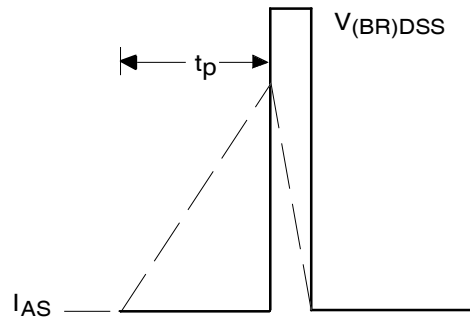

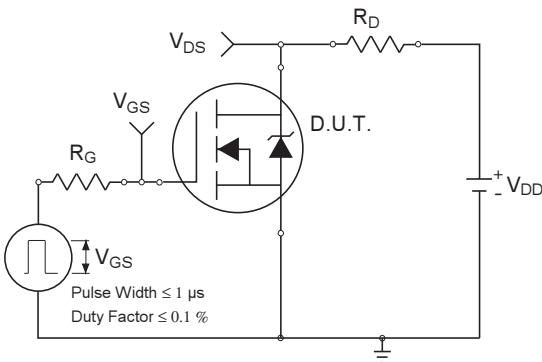
**Fig 23. Peak Diode Recovery dv/dt Test Circuit for N-Channel HEXFET® Power MOSFETs**



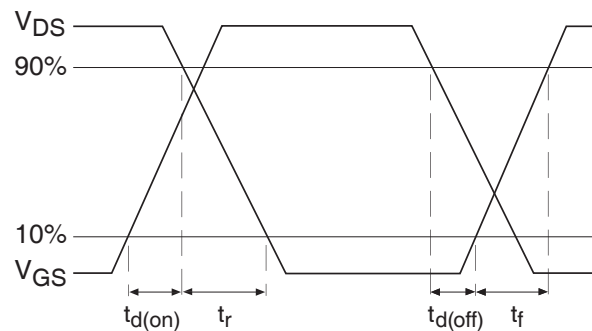
**Fig 24a. Unclamped Inductive Test Circuit**



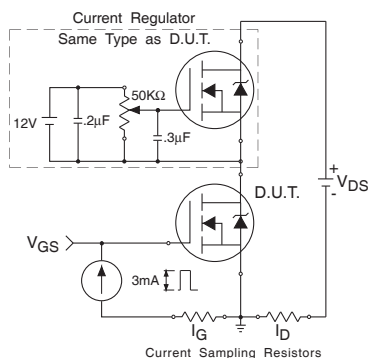
**Fig 24b. Unclamped Inductive Waveforms**



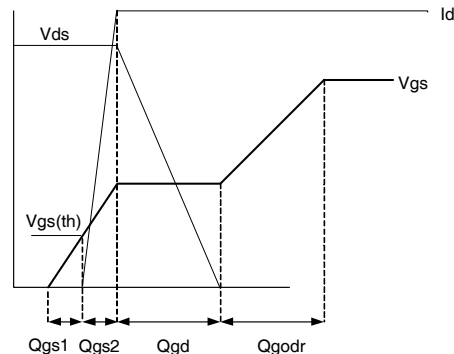
**Fig 25a. Switching Time Test Circuit**



**Fig 25b. Switching Time Waveforms**



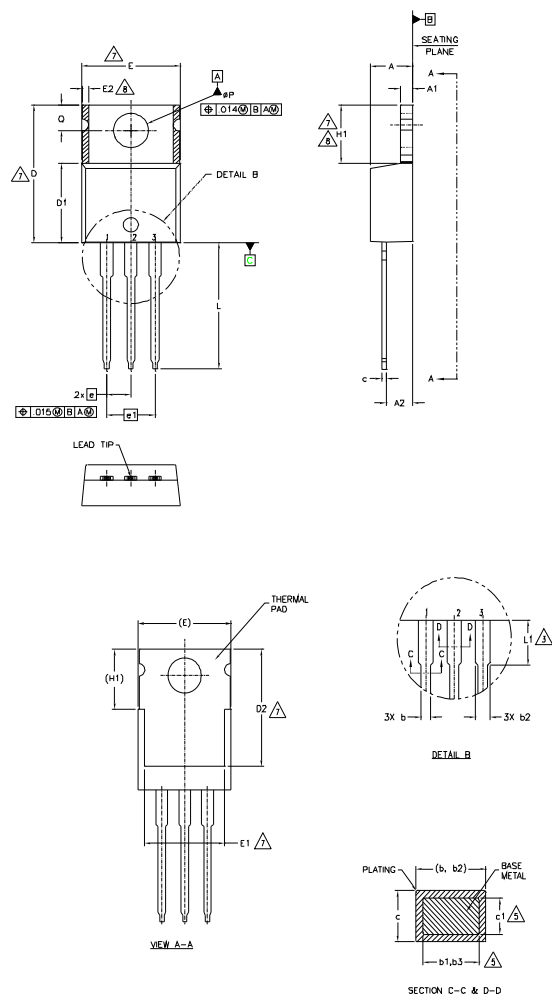
**Fig 26a. Gate Charge Test Circuit**

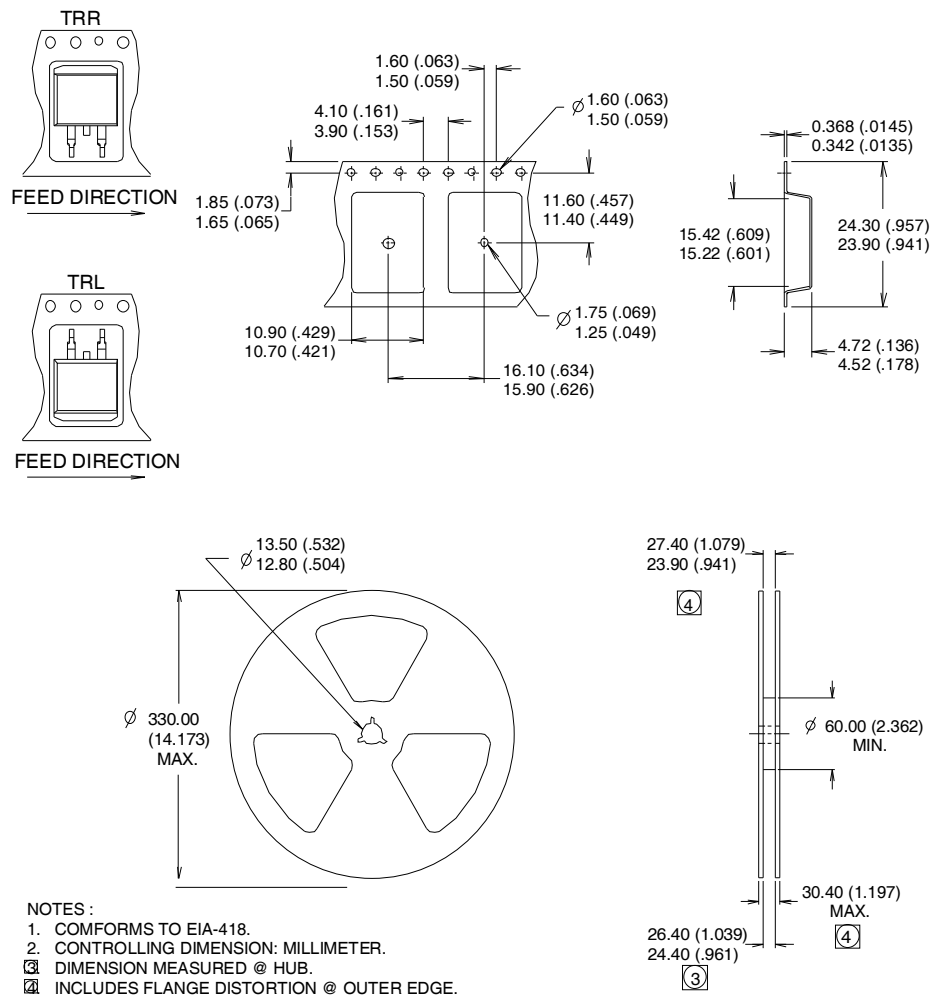
## D<sup>2</sup>Pak (TO-263AB) Part Marking Information
